PUPIL PREMIUM REPORT TO PARENTS/CARERS: 2018-2019 SCHOOL YEAR



OVERVIEW:

The Pupil Premium was introduced in April 2011, and paid by means of a specific grant per child based on school census figures for pupils who have been registered as eligible for FSM during the past six years (known as the Ever 6 Free School Meals measure) in Reception to Year 11 (£1320) and for looked after children the Pupil Premium was calculated using the Children Looked After data returns (£2300 grant per child in 2018-19). A premium is also given for children whose parents are currently serving in the armed forces (£300). This service premium is designed to address the emotional and social well-being of these pupils.

The Pupil Premium is additional to main school funding and it will be used by Egerton Primary School to address any underlying inequalities between children eligible by ensuring that funding reaches the pupils who need it most.

OBJECTIVES FOR PUPIL PREMIUM IN THIS SCHOOL:

1. The Pupil Premium will be used to provide additional educational support to improve/accelerate the progress and to raise the standard of achievement for these pupils.
2. The funding will be used to narrow and close the gap between the achievement of these pupils and their peers.
3. As far as our powers allow we will use the additional funding to address any underlying inequalities between children eligible for Pupils Premium and others.
4. We will ensure that the additional funding reaches the pupils who need it most and that it makes a significant impact on their education and lives.

IMPACT OF THE PUPIL PREMIUM IN THIS SCHOOL:

1. A review of the spending is carried out at the end of each term through analyzing the impact of the spending through measuring academic and personal progress
2. Upon reviewing the impact decisions on how the pupil premium will be spent for the following term are made

SCHOOL POLICY:

The Headteacher and governing body (led by the Finance Committee) have agreed a policy for Pupil Premium to guide the use of funds and to ensure that it represents value for money.

ACCOUNTABILITY:

The headteacher and SLT (Senior Leadership Team) will strategically plan the use of the Pupil Premium grant, creating a termly Pupil Premium Provision map, and regularly and rigorously monitor, evaluate and review the strategies we have put into place for Pupil Premium and report to the governing body on its progress and impact.

STATISTICS:

- In school, during the 2018-19 financial year, we have 17 pupils who were entitled to benefit from the additional funding at some point during the year.
- In the 2018-19 financial year, the school will receive £24,400 additional Pupil Premium funds.

STRATEGY FOR USING THE FUNDING:

The school has looked carefully at the needs of each pupil, and has tracked Pupil Premium spending in detail on a Pupil Premium Provision Map, to ensure that all Pupil Premium funding is targeted at those pupils who need it. Pupils' progress data is tracked closely each term to monitor the success of each intervention/activity. During the 2018-2019 financial year, we will use these additional funds for the following interventions with a view to achieve our objectives:

1:1 and small group interventions

- Additional guided reading
- Pre teaching of maths and writing skills to ensure children are ready to access their learning
- Booster sessions
- Phonic support to develop reading and spelling strategies
- Targeted 1:1 and small group feedback on learning

Enrichment Activities to extend life experiences/chances

- Private music lessons and exams.
- Football Team subscription costs.

Contribution towards Trips/Visits such as:

- Swimming coach costs.
- Chester Zoo Trip.
- Pensarn Residential.
- Beeston Residential

Equipment/Resources

- Benchmarking of reading.
- Summative assessment resources

Staffing

- A member of the SLT to monitor and promote good attendance of all pupil premium pupils, liaising parents/carers.
- Staff in school to deliver further learning opportunities
- Staff in school to monitor the effectiveness of interventions implemented
- An additional teacher during maths' lessons in Years 6, to facilitate small set focused teaching.

If you believe that your child is entitled to Free School Meals, but you are not currently claiming them then the school will not be given Pupil Premium funding to spend on your child.

Cheshire East awards free school meals to families that receive the qualifying incomes as follows, and whose children attend a Cheshire East school: Income support (IS); Income Based Jobseekers Allowance (IBJSA); Income-related Employment and Support Allowance (ESA(IR)); support under part VI of the Immigration and Asylum Act 1999; Child Tax Credit, provided you are not entitled to Working Tax Credit and have an annual income (as assessed by Her Majesty's Revenue and Customs) that does not exceed £16,190; The Guarantee element of State Pension Credit. If you have recently become unemployed or have reduced your working hours and have been granted the four week
